Healthcare System"

The ongoing False Claims Act litigation against Tuomey Health Systems presents important issues about the government's approach to litigating Stark issues. Like *U.S. v. Anderson* in the 1990s, the case provides a unique look at the thin line that may separate legal advice and claims of conspiracy. This presentation will examine what *Tuomey* has to tell us about the ethical and legal challenges facing lawyers and their clients in physician-hospital transactions.

"Physician Compensation -- In the Crosshairs?"

Traditionally the Government has focused its enforcement efforts, with some exceptions, on institutional providers. Indeed, hospitals have long complained that physicians can cause some problems under Stark but do not suffer the results of a non-compliant arrangement. Recent enforcement actions, however, suggest that the OIG and DOJ are paying attention to physician groups that do not structure correctly their compensation within the group, or enter into non-FMV arrangements with hospitals. This session will cover the rules for compliant physician compensation arrangements with hospitals and in group practices and offer some practical tips for staying out of the Government's sights.
